The contest "CSV NAME THE VIRTUAL ASSISTANT @ UNTOLD" organized during the festival UNTOLD 2019 is designed and administered by SC Softvision SRL ("Softvision", "Organizer"), a Romanian company based in Cluj Napoca, str. Republicii no.57 -59, ap.3, Cluj county, fiscal code RO10938454, registered with the Trade Register under no. J12 / 1345/1998.</p> <p>1.2. By organizing this Contest, Softvision aims to promote the Softvision brand, find a name that is most suggestive for the virtual assistant owned by the organizer and involve participants in interesting activities during the Untold 2019 event.</p> <p>1.3. The present concept and format of the contest represents an object of the copyright of the organizer, being protected according to the provisions of Law no.8 / 1996 on copyright and related rights.</p> <p>2. Period and place of the contest</p> <p>The contest takes place on the territory of Romania, through the platform https://untold.cognizantsoftvision.com/, held by the organizer, during the period 30-31 July at 24:00, respecting the participation criteria and the mechanism of the contest described by the current regulation.</p> <p>3.
